## **ORDERS BY THE GOVERNOR: MANIPUR**

Imphal, the 22<sup>nd</sup> April, 2022

**No. 7(2)/16/2018-HE:** Whereas, consequent upon the taking over of 6 Aided Colleges including Standard College, Kongba and its conversion into a full-fledged Government College under the Higher & Technical Education Department, Manipur vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 28.06.2018, the Administrative Department had appointed H. Inaobi Singh as Librarian under 'Unqualified (Approved) staff vide Government order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 wherein his date of joining is given as 19.02.1994, with due concurrence of Finance Department (PIC);

2. and whereas, the Sr. Accounts Officer (GOE), Manipur vide letter No. GOE/COLLEGE/2012/POLICY-IV/2018-19/2754 dated 28.11.2019 had requested the Administrative Department of Higher & Technical Education to give clarification in respect H. Inaobi Singh, Librarian, Standard College as detailed below:

H. Inaobi Singh, Librarian, Standard College	As per entries made in service book as available records, he was appointed as Counter Attendant vide GB Order No. A- $4/SC/94$ -AP- $9/1257$ dated 18.02.1994 and joined on 19.02.1994. He was promoted to the post of Librarian vide GB order No. SC/12-GB/Odr-(Pt. 1)/15 dated 06.06.2015. However, in the Annexure to the Govt. order dated 07.03.2019, his service and pay was protected as Librarian w.e.f. 19.02.1994 including service period of Counter Attendant	The Protection of past service and pay of Counter Attendant as Librarian may be reviewed and clarified.

3. and whereas, the Director of University & Higher Education vide letter No. 3/3-36/ 5-UHE(Pt. I)257 dated 14.01.2020 had proposed the following:

"His date of joining may be corrected as 06.06.2015 i.e. the date he was promoted to the post of Librarian. But his date of joining as Counter Attendant may be kept as 19.02.1994 i.e. date of his initial joining."

4. and whereas, as enquired by Finance Department (PIC), when the matter was referred to FD(PIC), the Director (Univ. & Hr. Edn.), Manipur vide letter No. 3/3-36/15-UHE(Pt-I)(Vol. V) dated 18.01.2021 had f. nished following details:

- i. H. Inaobi Singh u as appointed to the post of Counter Attendant at Standard College vide Order No. A-4/SC/94(AP-9)1257 dated 18.02.1994. He was promoted to the post of Assistant Librarian vide order No. SC/APL-3/(Pt-1)07 dated 17.02.2015 after he had acquired Bachelor of Library and Information Science in 2005. Later, he was promoted to the post of Librarian vide Order No. SC/12-GB/Odr-(Pt.I)/15 dated 06.06.2015 as he had also passed Master of Library & Information Science in 2013.
- ii. He was not qualified to be appointed to the post of College Librarian as per UGC RR, 20 0. However, he was promoted to the post of Librarian when he was serving in an Aic ed College and the qualifications for appointment in Aided Colleges are governed by provisions under Manipur Education Code, 1982. Subsequently, he was also appointed as Librarian (approved post) by the Government vide Order No. 3/3-335/81-EDC (Vol. III)A dated 15.12.2016.
- iii. He had obtained NOC from the Principal of Standard College for pursuing Bachelor of Library & Information Science vide Order No. SC/14-PRL/(P-2):2 dated 10.03.2002 and Master of Library & Information Science vide Order No. SC/14-Pr. dated 08.03.2012.

5. and whereas, the matter was again moved to the Finance Department (PIC) for their views/comments and FD(PIC) has cited the following:

"As per verif tion sheet/report from Administrative Departmet and relevant records/appointment orders issued by the then Governing Body of Standard College, FD(PIC) agrees to the correction of date of joining in the appointment/sbaorption order dated 07.03.2019 in respect of Shri H. Inaobi Singh, Librarian, Standard College in the following manner:
