**ORDERS BY THE GOVERNOR : MANIPUR**

Imphal, the 21<sup>st</sup> June, 2022

**No. 14(9)/6/2019-HE(B)(CONVSN):** Whereas, consequent upon the taking over of Standard College, Kongba and 5 (five) other erstwhile Aided Colleges and its conversion into a full-fledged Government Colleges, the Administrative Department of Higher & Technical Education had appointed Saheeda Begum & H. Chandrabala Devi of Standard College, Kongba as 'Lecturer' in English & Political Science subject respectively vide appointment order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 under the Category 'Unqualified (Unapproved)' Group as per the report of the Verification Committee and with due concurrence of Finance Department (PIC);

2. Whereas, as approved by the State Cabinet in its sitting held on 20.04.2020, the Administrative Department of Higher Education, Manipur vide Order No. 31/3/AIDED-COL/CONVSN/HE(EIN) dated 27.05.2020 had created 71 supernumerary post of Lecturers for 71 Lecturers of 7 erstwhile Aided Colleges, including Saheeda Begum & H. Chandrabala Devi, in the pay scale of Rs. 9300-34800 + GP Rs. 4400/- to fit the unqualified teachers in the newly created posts subject to the following conditions:

- i) To freeze the 71 nos. of newly created posts of Assistant Professor in the EIN for the time being;
- ii) Upgradation of the said Lecturers to Assistant Professor after acquiring the requisite educational qualification for the post of Assistant Professor and thereafter, abolish the post of Lecturers held by them.
- iii) The Lecturers who are not qualified under the relevant Government College Lecturer Recruitment Rules under UGC Regulation against the created/converted post shall be treated as Lecturer and they shall be considered in the Scale of PB-2: Rs. 9300 – 34, 800/- plus FP of Rs. 4400/- p.m. till they get qualified as per the existing recruitment rules by giving them one time opportunity to improve their educational qualification to pursue either NET/M. Phil/Ph. D. Degrees as the case may be, as per relevant UGC norms within the period of 5 (five) years from the date of issue of order for conversion into full-fledged as done in the case of regularisation of 418 Part-time Lecturers vide Government order No.7(2)/9/2005-S/HE(Pt. III) dated 12.04.2017. After acquiring requisite educational qualification i.e. either M. Phil or NET or Ph. D. Degrees, they shall be entitled for the pay-scale of PB-3: Rs. 15,600-39,100 plus AGP of Rs.6000/- p.m. with the designation as Assistant Professors at par with qualified Assistant Professors.

3. Whereas, the Director, University & Higher Education, Manipur vide letter No. DUHE-17/15/2021-DUHE-DU&HE dated 17.01.2022 had furnished a fresh report of the Verification Committee regarding the rectification of status of qualification in respect of the forementioned 2 (two) teaching staff of Standard College;

4. And Whereas, Finance Department (PIC) was moved for views/comments on the re-verification report of the Verification Committee and views of the Finance Department (PIC) is reproduced below:

*"As per recommendation of the Verification Committee in its report dated 17.01.2022, FD(PIC) agrees for inclusion of the newly appointed 2 (two) teaching staff of erstwhile Govt. Aided College, namely, Standard College, Kongba in the qualified list of Assistant Professor (in PB: Rs. 15600-39100+AGP Rs. 6000) in the following manners:-*
