ORDERS BY THE GOVERNOR : MANIPUR

Imphal, the 7th July, 2022

No. UHE-18014/1/2020-HTE-DHTE: Whereas, consequent upon the taking over of 6 (six) Aided Colleges including Liberal College, Luwangsangbam and its conversion into a full-fledged Government College under the Higher & Technical Education Department, Manipur, the Administrative Department had appointed L. Nolini Chanu as 'Lecturer in Philosophy' vide Government Order No. 31/3/AIDED-COL/CONVSN/HE-16 dated 07.03.2019 under the category 'Unqualified (Unapproved)' as per the Verification report of the Verification Committee with due concurrence of the Finance Department (PIC);

2. Whereas, as approved by the State Cabinet in its sitting held on 20.04.2020, the Administrative Department of Higher Education, Manipur vide Order No. 31/3/AIDED-COL/CONVSN/HE(EIN) dated 27.05.2020 had created 71 supernumerary post of Lecturers for 71 Lecturers of 7 erstwhile Aided Colleges, including L. Nolini Chanu, in the pay scale of Rs. 9300-34800 + GP Rs. 4400/- to fit the unqualified teachers in the newly created posts subject to the following conditions:

- i) To freeze the 71 nos. of newly created posts of Assistant Professor in the EIN for the time being;
- ii) Upgradation of the said Lecturers to Assistant Professor after acquiring the requisite education qualification for the post of Assistant Professor and thereafter, abolish the post of Lecturers held by them.
- iii) The Lecturers who are not qualified under the relevant Government College Lecturer Recruitment Rules under UGC Regulation against the created/converted post shall be treated as Lecturer and they shall be considered in the Scale of PB-2: Rs. 9300 – 34, 800/- plus FP of Rs. 4400/- p.m. till they get qualified as per the existing recruitment rules by giving them one time opportunity to improve their educational qualification to pursue either NET/M. Phil/Ph. D. Degrees as the case may be, as per relevant UGC norms within the period of 5 (five) years from the date of issue of order for conversion into full-fledged as done in the case of regularisation of 418 Part-time Lecturers vide Government order No.7(2)/9/2005-S/HE(Pt. III) dated 12.04.2017. After improving themselves upto their requisite educational qualification i.e. either M. Phil or NET or Ph. D. Degrees, they shall be entitled for the pay-scale of PB-3: Rs. 15,600-39,100 plus AGP of Rs.6000/- p.m. with the designation as Assistant Professors in parity with qualified Assistant Professors.

3. Whereas, the Director, University & Higher Education, Manipur vide letter No. DUHE-17/7/2022-DUHE-DU&HE dated 10.02.2022 had furnished a re-verification report of the Verification Committee regarding the rectification of status of qualification in respect L. Nolini Chanu;

4. Whereas, after careful examination, the Administrative Department of Higher & Technical Education, Manipur had also issued an order No. UHE-18014/1/2020-HTE-DHTE dated 13.05.2021 stating that the Certificate of Ph. D. Degree awarded by CMJ, University, Meghalaya in favour of L. Nolini Chanu, Lecturer (Philosophy) of Liberal College, Luwangsangbam shall be treated as legal/genuine/legitimate certificates in the State of Manipur for the purpose of her services in the Government/Government Aided Colleges;

5. And whereas, the matter regarding the re-verification report of the Verification Committee was referred to Finance Department (PIC) for concurrence and FD (PIC) has agreed to the upgradation of qualification status in respect of L. Nolini Chanu, Lecturer (Philosophy) of Liberal College, Luwangsangbam:

Nolini Chanu (Philosophy) of Liberal College, Luwangsangbam, as concurred by Finance Department (PIC) as detailed in the Table at Para 5 above, on having acquired the requisite educational qualification subject to abolishing of existing Lecturer in the concerned subject held by her.
