NOTIFICATION

Imphal, the 23rd November, 2023

No. APPT-4/3/2020-DP-DPb : In exercise of the powers conferred by the Proviso to Clause (3) of Article 320 of the Constitution of India, the Governor of Manipur hereby makes the following regulation further to amend the Manipur Public Service Commission (Exemption from Consultation) Regulations, 1972 namely:-

1. **SHORT TITLE AND COMMENCEMENT:**

- (1) These regulations may be called the Manipur Public Service Commission (Exemption from Consultation)(Amendment) Regulations, 2023.
- (2) They shall come into force on the date of their publication in the Official Gazette.

2. **Addition of Regulation 124 - After regulation 123 of the Manipur Public Service Commission (Exemption from consultation) Regulations, 1972, the following regulation shall be added, namely:**

“124 - It shall not be necessary to consult the Commission (MPSC) with regard to appointment by promotion in the offices/Departments under the Government of Manipur during the Period till the existence of the Commission of Manipur Public Service Commission including cases for which requisitions/proposals for concurrence have been made to Manipur Public Service Commission but not yet recommended by the Commission.

DPC composition during this period shall be as follows:

Class-I DPC:

1.	Chief Secretary, Government of Manipur	Chairman
2.	Commissioner/Secretary (DP), Govt. of Manipur	Member
3.	Commissioner /Secretary of the Department concerned	Member

Class-II DPC:

1.	Chief Secretary/Addl. Chief Secretary, Govt. of Manipur	Chairman
2.	Commissioner/Secretary of the concerned Department	Member
3.	Head of Department concerned	Member

1. SHORT TITLE AND COMMENCEMENT:

- (1) These regulations may be called the Manipur Public Service Commission (Exemption from Consultation)(Amendment) Regulations, 2023.
- (2) They shall come into force on the date of their publication in the Official Gazette.

2. Addition of Regulation - After regulation of the Manipur Public Service Commission (Exemption from consultation) Regulations, 1972, the following regulation shall be added, namely:

“124 - It shall not be necessary to consult the Commission (MPSC) with regard to appointment by promotion in the offices/Departments under the Government of Manipur during the Period till the existence of the Commission of Manipur Public Service Commission including cases for which requisitions/proposals for concurrence have been made to Manipur Public Service Commission but not yet recommended by the Commission.

Class-I DPC:

1.	Chief Secretary, Government of Manipur	Chairman
2.	Commissioner/Secretary (DP), Govt. of Manipur	Member
3.	Commissioner /Secretary of the Department concerned	Member

Class-II DPC:

1.	Chief Secretary/Addl. Chief Secretary, Govt. of Manipur	Chairman
2.	Commissioner/Secretary of the concerned Department	Member
3.	Head of Department concerned	Member
