## **NOTIFICATION**

No. 4/85/2022-Judl/L: In exercise of the powers conferred by section 16 of the Manipur (Courts) Act, 1955 (56 of 1955) read with section 9 and 11 of the Code of Criminal Procedure, 1973 (2 of 1974), the Governor of Manipur after consultation with the High Court of Manipur is pleased to establish the following Court at Column (II) within the territorial limit of its jurisdiction at Column (III) shall extend, its ordinary place of sitting at Column (IV) and date of functional at Column (V) in the <u>Schedule</u> below:-

2. This issues in the second phase towards the implementation of judgement dated 19-04-2012 passed by the Supreme Court of India in T.C.(C) No. 22 of 2001 (Brij Mohan Lal – Vs- Union of India & Ors) to increase strength of judges in the State by 10% and in compliance of the recommendations of the Advisory Council to the National Mission for Justice Delivery and Legal Reforms to make double the number of existing Courts in five years. This notification is also issued in compliance of order dated 09-06-2022 of the Hon'ble High Court of Manipur passed in PIL No. 47 of 2021 (Forerunner -vs State of Manipur & Ors).

3. This issues in partial modification of previous notification no. 4/6/2017-Judl/L dated 27-06-2018 and thereby deleted the word 'Tamenglong' at sl. no. 2 column (III) of the said notification.

4. The expenditure is debitable from Major Head 2014 Administration of Justice, Sub-Major 00, Minor 105 Civil and Session Courts, Sub-Head 26 District Sessions Courts, Tamenglong, Detailed 00, Object 01 Salary, 02 Wages, 11 Domestic Travel Expenses,13 Office expenses under Demand No. 26 Administration of Justice. 5. This issues with the approval of State Cabinet and concurrence of Finance Department (PIC) vide their U.O. No. 99/2014-2015-/FD(PIC) dated 08-09-2014.

6. This supersedes previous notification of even number dated 06-07-2022.
