**NOTICE FOR DE-NOTIFICATION OF LAND MEASURING 4.92 ACRES SET APART FOR PLAYGROUND  
OF STAR SPORTING CLUB, POROMPAT**

(UNDER RULE NO 14 OF MANIPUR LAND REVENUE & LAND REFORMS RULES, 1961)

No. DC(IE)/9/175/2003/57 : Whereas, DC Imphal East vide Order of even No. dated 30<sup>th</sup> December, 2003, in exercise of the powers conferred under Section 13 of the MLR&LR Act 1960 had de-reserved an area of 4.92 acres of land from being "Grazing Ground" and set apart for playground of Star Sporting Club, Porompat;

2. Whereas, Government of Manipur: Revenue Department vide Letter No. LDM-101/74/2022-REV-REVENUE dated 19<sup>th</sup> July, 2022 has conveyed approval for de-notification of the land measuring 4.92 acres set apart for playground of Star Sporting Club, Porompat unde Rule 14 of Manipur Land Revenue & Land Reforms Rules, 1961.

3. Whereas, the land in question has seen many illegal encroachments/structures coming up like car washing centre, workshop, community hall, etc. as per the report of SDO Porompat vide her letter No. 12/SDO(P)/IE/2021/2787 dated 22<sup>nd</sup> December, 2021;

3. Whereas a part of the land set apart as playground is seen to be the dumping ground which may be detrimental to the health of human beings and needs to be protected and conserved and lots of encroachments have been seen to be taking place in the surrounding areas;

5. Whereas, the ground is being used by the District Administration, Imphal East for observing National Functions and is located right next to the DC Approach Road;

6. Whereas, proposal for construction of New Mini Secretariat Complex of Imphal East District is underway by amalgamating the lands occupied by the offices of SDO Porompat, Inspector of Schools Zone II, District Fishery Officer, DSWO, DPO, SDC Keirao, SDC Tuliha and the land mentioned in Para No. 1;

7. Whereas, it has become necessary that the land specified in the schedule below may be de-notified from being set apart for playground of Star Sporting Club, objection, if any, may be made within 30 (thirty) days from the date of issue of this Notice.
