No. RRDP-34/1/2022-DP-DP(A): In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and other powers enabling him in this behalf, the Governor of Manipur is pleased to make the following rules further to amend the Manipur Electrical and Mechanical Engineering (PWD) Service Rules, 2016, namely :-

- 1. Short title and commencement :
 - 1) These rules may be called the Manipur Electrical and Mechanical Engineering (PWD) Service (2nd Amendment) Rules, 2022.
 - 2) These rules shall come into force from the date of notification in the State Gazette.

2. The existing Sl. No. 5 of table in SCHEDULE –III [see rule 7(ii)] to the Manipur Electrical and Mechanical Engineering (PWD) Service Rules, 2016 shall be substituted by the following :-

Method of recruitment, field of promotion and minimum qualifying service in the immediate lower grade/grades for appointment of officers on promotion to duty posts included in the various grades of the Manipur Electrical and Mechanical Engineering Service (PWD):
