Purnachandra Singh, Ward No. 2, Ex-Councillors, IMC submitting their objections/suggestions in pursuance of Hon'ble High Court of Manipur's order dated 29.12.2022 passed in connection with W.P.(C) No. 1121 of 2022 and it was disposed of by issuing a speaking order;

NOW, THEREFORE, the Governor of Manipur is pleased to finalize and to notify the reservation of seats for SC/ST, SC/ST (Women) and Women in respect of Imphal Municipal Corporation as per the result of the lottery held on 7-10-2022 as it was done as per rules without any defect.
