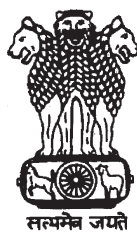

## NOTICE OF ELECTION

Imphal, the 31st May, 2013

No.1/01/2013-RO(MSVC) : In pursuance of clause (a) of sub-rule (1) of section 32 of the Indian Veterinary Council Act, 1984 and read with rule 3.1, 3.8, 3.9, 3.12 and 3.14 of the Manipur State Veterinary Council Rules, 1987, I, the undersigned hereby notify to all the persons enrolled in the Manipur State Veterinary Register maintained under Chapter VII of the said Act, that 7<sup>th</sup> Election of Manipur State Veterinary Council, will be held on the 15<sup>th</sup> July 2013, to fill up 4 (four) seats for the members of the said State Council as per schedule shown below :-

1. Form of nomination paper may be obtained from the office of the Manipur State Veterinary Council, Sanjenthong from 1<sup>st</sup> June to 7<sup>th</sup> June 2013, between 10:00 AM to 3:00 PM of all working days.
2. Nomination papers may be delivered by registered post with acknowledgement or deliver in person to the Returning Officer ( Under Secretary, Vety. & A. H. Government of Manipur) Room No. 112 Manipur Secretariat Annex New Building, Imphal -795001, between 10:00 AM to 3:00 PM on any working day (other than public holiday) not later than the 7<sup>th</sup> June 2013.
3. Nomination paper will be taken for scrutiny on the 10<sup>th</sup> June, 2013 at 3:00 PM.
4. Notice for withdrawal of candidates may be delivered by the candidate in writing signed by him and deliver to the Returning Officer before 3:00 PM on 12<sup>th</sup> June, 2013.
5. List of contesting candidates will be published on the 12<sup>th</sup> June, 2013 itself.
6. Voting papers will be sent to every electorate as per Electoral roll by post starting right from 15<sup>th</sup> June, 2013.
7. Completed Voting papers from the electors will be received by the Returning Officer either by post or by hand up to 2:00 PM of 15<sup>th</sup> July. 2013 only.
8. Counting of Votes will be taken on 15<sup>th</sup> July, 2013 (day of polling) at the office of the Manipur State Veterinary Council, Sanjenthong, Imphal, at 2:30 PM and the result will be declared on the same day.
