No. 2/16/2019-Leg/L: The following Act of the Legislature, Manipur which received assent of the Governor of Manipur on March 20, 2019 is hereby published in the Official Gazette:

THE MANIPUR LOKTAK LAKE (PROTECTION) (THIRD AMENDMENT) ACT, 2019 (MANIPUR ACT NO. 8 OF 2019)

AN

ACT

further to amend the Manipur Loktak Lake (Protection) Act, 2006.

Be it enacted by the legislature of Manipur in the Seventieth Year of the Republic of India as follows:-

1. (1) This Act may be called the Manipur Loktak Lake (Protection) (Third Amendment) Act, 2019.

Short title and commencement.

- (2) It shall be deemed to have come into force with effect from the 1st February, 2019.
- 2. In the Manipur Loktak Lake (Protection) Act, 2006 (hereinafter referred to as the Principal Act), for section 7, the following shall be substituted, namely:-

Substitution of section 7.

"7. Composition of the Loktak Development Authority.-

The Authority shall consist of the following members, namely-

1. Chairman (to be appointed by the State - Chairman Government)

3. For section 8 of the principal Act, the following shall be substituted, namely:-

Substitution of section 8.

- **"8.** Terms and conditions of Services of Chairman/Vice-Chairman/Non-official Members:- The terms of office and conditions of service of the Chairman/Vice Chairman/non-official member of the Authority shall be such as may be prescribed by the State Government.".
- 4. In section 9 of the Principal Act, for sub-section (i), the following shall be substituted, namely:-

Amendment of section 9.

- "(i) The Chairman/Vice-Chairman may at any time, by writing under his hand addressed to the State Government, resign his office; and a non-official Member may at any time, by writing under his hand addressed to the Chairman of the Authority, resign his office.".
- 5. For section 10 of the Principal Act, the following shall be substituted, namely:-

Substitution of section 10.

- **"10.Removal of Chairman/Vice-Chairman/Members:-** The State Government may remove from the Authority, Chairman/Vice-Chairman or any Member who, in its opinion has-
- (a) been adjudged as an insolvent; or
- (b) been convicted of an offence which involves moral turpitude; or
- (c) become physically or mentally incapable of acting as a member, or
- (d) so abused his position as to render his continuance in office detrimental to the public interest; or
- (e) acquired such financial or other interest as is likely to affect prejudicially his functions as a member.".

Repeal and savings.

- 6. (1) The Manipur Loktak Lake (Protection) (Third Amendment) Ordinance, 2019 is hereby repealed.
- (2) Notwithstanding such repeal, anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under the corresponding provisions of this Act.
