No. 2/RO/SDO/PSI/GEN/ELEC/2012 : In pursuance of Section 31 of the Representation of the people Act, 1951 read with Rule 3 of the conduct of Election Rules, 1961 and further in pursuance of Notification No.464/MR-LA/2012 dated 4<sup>th</sup> January, 2012 of the Election Commission of India and Notification No. 4/1/Elec-Notfn/SAE-2012 dated 4<sup>th</sup> January, 2012 issued by the Chief Electoral Officer, Manipur, notice is hereby given that :

- An election is to be held of a member to the Manipur Legislative Assembly in the 18-Konthoujam Assembly Constituency.
  - Nomination paper may be delivered by a candidate or by any of his proposers to the Returning Officer or to Shri Suleiman Daulat Khan, Sub-Deputy Collector (Konthoujam)/ Assistant Returning officer of 18-Konthoujam Assembly Constituency at the office of the Returning Officer/SDO (Patsoi), (DC,Imphal West, Office Complex, Lamphelpat) between 11 A.M. and 3 P.M. on any day (other than public Holiday) not later than the 11<sup>th</sup> January, 2012.
  - 3. Forms of nomination paper may be obtained at the place and time aforesaid.
  - The nomination papers will be taken up for Scrutiny at 11 A.M. on the 12<sup>th</sup> January, 2012 at the office of the Returning Officer/SDO (Patsoi), DC (I/W) Office Complex, Lamphelpat.

Notice of withdrawal of candidature may be delivered either by a candidate or by any of his proposers or by his election agents who has been authorized in writing by the candida<sup>++</sup> to deliver it to either of the officers specified in paragraph (2) above at his office being 3 P.M. on the 14<sup>th</sup> January, 2012.
- 6. In the event of the election being contested, the poll will be taken on the 28<sup>th</sup> January, 2012 between the hours of 7 A.M. and 3.00 P.M.
