M. and 3:00 P.M. on any day (other than public holiday) not later than the 11<sup>th</sup> January, 2012 (Wednesday);
- (3) forms of nomination paper may be obtained at the place and time aforesaid;
- (4) nomination papers will be taken up for scrutiny at 11:00 A.M. on the 12<sup>th</sup> January, 2012 (Thursday) at the office of the SDO/Returning Officer, Lamphel, Imphal West;
- (5) notice of withdrawal of candidature may be delivered either by a candidate or his proposer or his election agent (who has been authorized in writing by the candidate to deliver it) to either of the officer Specified in paragraph (2) above at his office before 3:00 P.M. on the 14<sup>th</sup> January, 2012 (Saturday);
- (6) in the event of the election being contested, the poll will be taken on the 28<sup>th</sup> January, 2012 (Saturday) between the hours of 7:00 A.M. and 3:00 P.M.
