NOTIFICATION

Imphal, the 12th July, 2013

No.9/1/98-CHA(Pt-II): Whereas the result of the village Authorities Elections held in 2012 for 424 villages in respect of the following 4(four) sub-Divisions of Tamenglong District have been submitted to the Government by the Deputy Commissioner, Tamenglong as per rule 13 of the Rules for the conduct and election of Members of the Village Authorities vide his letter No.DC(TML)VA-12/ELN/IC/12 dated 03-12-2012 under the Manipur (Village Authorities in Hill Areas) Act, 1956

- (1) Tamenglong(HQ) Sub-Division
- (2) Tamei Sub-Division
- (3) Tousem Sub-Division
- (4) Nungba Sub-Division

2. Whereas, the Deputy Commissioner, Tamenglong vide his letter No.DC(TML)VA-12/ELN/IC/12 dated 03-12-2012 proposed to set aside the results of Village Authority Elections in respect of certain villages under Tamenglong District due to problems/disputes in the villages.

3. Whereas, the Hon'ble Gauhati High Court in its judgment & order dated 06-05-2013 in W.P.(C) No.124 of 2013 directed to notify the election results of Taosang Village Authority.

4. Whereas, Shri Tamjanlung of Taosang Village ex-officio Chairman of Taosang Village was not considered for the post of ex-officio Chairman due to a dispute regarding his resident status.

5. Therefore, the Governor of Manipur is pleased to accord approval to the declaration of the elected persons as Members of the Village Authority of Taosang Village, Nungba Sub-Division under Tamenglong District as per the ANNEXURE appended hereto. The declaration of the Chairman shall be notified as and when the aforementioned dispute is settled.

6. This Notification shall come into force from the date of its publication in the Official Gazette of Manipur.
