TnC-204/1/2022-TCI-T,C&I I: In pursuance of the recommendations of the Inter-Ministerial Committee (IMC), Ministry of Development of North Eastern Region, Government of India for integration of Industry 4.0 in manufacturing and strengthening of logistics in North Eastern Region, and as approved by the Governor-in-Council in its meeting held on 29.05.2025, the Governor of Manipur is pleased to accord "Industry Status" to the Logistics Sector in the State of Manipur.

2. Consequent upon the grant of Industry Status, all logistics and warehousing units established or to be established in the State of Manipur shall be eligible to avail benefits and incentives under the extant Manipur Industrial and Investment Promotion Policy 2022 and other relevant schemes of the State Government, subject to terms and conditions as prescribed therein.

3. This Notification shall come into force with effect from the date of its publication in the Official Gazette.
